The Tiger Zone program requires all participants to follow the RCES rules and student behavioral expectations during all Tiger Zone activities, including the bus ride home.

The Tiger Zone program will follow a **THREE STRIKE** behavior policy. It is the intention of the Tiger Zone program that minor behavioral issues be handled by the individual activity instructors. A student will be referred to the building site manager for major behavioral issues.

Major behavioral issues include, but are not limited to:

1. Physical aggression toward other students, staff, or school property
2. Verbal disrespect or profanity toward other students, staff, or school property
3. Verbal disrespect or physical aggression on the bus.

Any referral to the building site manager will result in the student being issued a **Strike**. Any student that receives three strikes will be removed from the Tiger Zone program for the remainder of the semester.

- **Strike 1** - Student will receive a verbal warning from the site manager and will spend the remainder of the day in the Alternate TZ Classroom.
- **Strike 2** - Parents will receive a phone call and the student will spend the remainder of the day in the Alternate TZ Classroom.
- **Strike 3** - Parents will be called to pick up their student at RCES. Student will no longer be eligible to participate in the Tiger Zone Program for the remainder of the current semester.
